The EMD deposit shall not attract any interest.

**General Terms & Conditions:**

1. The bidders may inspect the car on a predetermined date and satisfy themselves about the car they are bidding for.
2. Bid letter in sealed envelope should be addressed to Director, National Gallery of Modern Art, Jaipur House, New Delhi-110003, superscribing the following "Bid" for disposal/sale of old Ambassador car.
3. The bid must reach Director, National Gallery of Modern Art, Jaipur House, New Delhi-110003 or before the due date.
4. The financial bid should be quoted both in figures and words along with Sales Tax if any. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the tenderer. Sales Tax shall be borne by the bidder.
5. NGMA, New Delhi reserves the right to reject bids without assigning any reason whatsoever.
6. Financial bid should be signed by the bidder(s).
7. Incomplete and unsigned bids shall be rejected.
8. Bids without EMD shall be rejected.
9. The car shall be sold to the highest bidder inclusive of Sales Tax, if any on the basis of amount quoted in the bid.
10. The car, once disposed to the successful bidder, shall not be taken back by NGMA, New Delhi on any condition whatsoever.
