## Section – 1 Background of the project:

1. National Gallery of Modern Art, Delhi will hold an exhibition entitled Hastantaran to trace the artistic journey of Nandalal Bose (3 December 1882 – 16 April 1966), one of the pioneers of modern Indian art and a crucial figure of Contextual Modernism through his 150 artworks from NGMA collection. A disciple of Abanindranath Tagore, Bose was known for his "Indian style" of painting. He became the principal of Kala Bhavan, Santiniketan in 1922. His artistic style had influence of the murals of Ajanta; his classic works include paintings of scenes from Indian mythologies, women, and village life. His paintings are considered among India's most important modern paintings. He occupies a place in the history of Modern Indian art that combines those of Raphael and Durer in the history of the Renaissance. Like Raphael Nandalal was a great synthesizer, his originality lay in his ability to organize discrete ideas drawn from Abanindranath Tagore, Rabindranath Tagore, E. B. Havell, Ananda Coomaraswamy, Okakura Kakuzo and Mahatma Gandhi into a new art movement in India. The exhibition will be opened for public viewing on 26<sup>th</sup> February 2021.

## Section – 2 Objectives:

In order to provide and ensure proper execution of the exhibition designs as per scenography prepared by NGMA Curatorial and design team NGMA intends to engage an agency to manage the entire fabrication of the exhibition with the scope mentioned in this document. **Section – 3 Scope of Work:** 

Overall scope of work includes: -

- Preparation of exhibition hall as per design and scenography. (Annexure-1)
- Fabrication of exhibition space/installation props (indoor and outdoor). (Annexure- 2)
- Procurement of materials required for fabrication and preparation of exhibition hall.

## **01. Delivery Place:**

Bidder will supply and deliver the materials din requisite number at the office of "National Gallery of Modern Art, Delhi"

## 02. Qualification Conditions:

- a) Bidder should be registered establishment and should be authorized supplier/service provider of the quoted item/ work and should submit the relevant documents/certificates.
- b) Bidder should have experience of supplying such items and will have to furnish details of previous supplies.
- c) Bidder shall provide all relevant records required i.e. Income Tax Return Certificate/PAN, Commercial Tax Clearance/V.A.T. Certificate And other taxes (whichever applied)

## 03. Bid price:

- a) The contract shall be for a period of three months.
