GENERAL TERMS AND CONDITIONS FOR THE WORK OF SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF DIGITAL HARDWARE FOR JATAN MUSEUM BUILDER SOFTWARE SYSTEM FOR MODERN ART PRESERVATION FACILITY AT NGMA, NEW DELHI.

- 1. Server, Desktop, Camera may be supplied with the authorization from the OEM.
- 2. The Tenderer shall be required to take up the work of Supply, Installation, Testing and Commissioning of Digital Hardware for Modern Art Preservation Facility at NGMA, New Delhi.

3. Price:

The rates quoted/indicated shall include cost of materials and equipments required for the work as per the enclosed specification and installation charges. The V.A.T./C.S.T./Service Tax and other taxes/ levies to be imposed on the rate shall be clearly mentioned. Rate quoted shall be firm and fixed for the entire period of execution of the Work Oder and no escalation of rate on any ground whatsoever shall be applicable.

4. Time of completion:

Time is the essence of this contract. The time for supply, installation, testing and commissioning of aforesaid equipment is **10 days** from date of placement of work order. Order is liable to be cancelled if the aforesaid time schedule is not strictly followed, NGMA shall be entitled to claim appropriate liquidated damages. 5. Payment Terms

No advance payment shall be made by NGMA under any circumstances. Payment shall be released after satisfactory completion of the entire work within 15 (fifteen) days from the date of receipt of Invoice/Bill duly supported by receipted challan and satisfactory inspection/work completion certificate issued by the competent authority of NGMA.

- 6. Every effort should be made to complete the work by the successful Tenderer within the specified time schedule. In case the firm fails to comply with Clause No. 5 i.e., the specified time schedule as per the finalized and accepted terms and conditions, the NGMA shall have the right to cancel the order and forfeit the EMD. The decision of NGMA in this regard shall be final and binding on the successful Tenderer.
- 7. T.D.S. shall be deducted at source, if applicable, from the bill of firm as per prevailing Government Rules.

8. Defect Liability Period

The Defect Liability /Warranty period shall be **3 years** from the date of completion of supply and installation. The successful tenderer(s) shall be responsible for all defects of the equipments, manufacturing defects etc. for a period of 3 years from the date of completion of the supply and installation. The successful tenderer(s) shall rectify the defect/defective parts within the specified time upto the complete satisfaction of the competent authority of NGMA.

- 9. Bad quality equipments will not be accepted and if found liable to be rejected and should be replaced by the successful tenderer(s) at his cost as per specifications and directions given by the authorized representatives of NGMA.
- 10. Specification of the items under tender are enclosed for guidance. However, if any, ambiguity in the specification is detected, it shall be promptly brought to the notice of NGMA for clarification. The successful tenderer(s) without written approval of NGMA shall make no deviation from the approved specifications.
- 11. The NGMA does not bind itself to accept the lowest tender, and reserves the right to accept or reject any or all tenders wholly or partially without assigning any reason whatsoever.
- 12. The successful tenderer(s) shall obtain necessary trade and other licenses as may be required to carryout the tendered job and shall also be responsible for compliance of all rules and regulations which may be in force from time to time by the appropriate authority at his/their own cost.

13. Security Deposit

The Security Deposit shall be 10% of the gross value of the work order, shall be deducted from the Invoice/Final Bill No. The Security Deposit shall be released after expiry of the defect liability period of 3 years from the date of completion of the work.

- 14. Authorization letter from the manufacturer should be made available for quoting for their product, technical compliance to specification and for providing after sales support.
- 15. Address/contact number of the service centre available in New Delhi should be mentioned.
- 16. The warranty card to be duly singed by the manufacturer.
- 17. The warranty should be comprehensive and will start from the date of installation of the complete system.
- 18. Model upgrade if any at the time of supply should be indicated and latest model to be supplied. However, the latest upgrade should comply with all the specifications mentioned in the tender.

- 19. The tenderer should quote for the original equipment only. Refurnished/remanufactured items are not acceptable. The supplier has to provide documentary evidence by a certificate issued by the manufacturer stating the serial number and other details of the items shipped in original equipment with the manufacturing date.
- 20. Rates quoted should include of supply, installation, commissioning and maintenance of the equipment for the warranty period.
