- (2) The tenderer should have a local office in Delhi NCR.
- (3) The successful tenderer should have to supply, at site with cartage.
- (4) The successful bidder shall have to supply materials within 2 days from the date of the supply order.

- (9) Payment terms- No advance payment shall be made by the NGMA under any circumstances, payment shall be released after satisfactory supply of materials within 15 days from the date of receipt of Invoice/Bill duly supported by the competent authority of NGMA.

The successful tenderer(s) shall be responsible for all defects supply. The successful tender(s) shall rectify/replace for defect/defective materials within 03 days without any cost whatsoever upto the complete satisfaction of competent authority of NGMA.
- (11) The Director (NGMA) reserves the right to accept the tenders in totality or in parts thereof. The Director (NGMA) also reserves the right to accept or reject the tenders without assigning any reasons.
