# GENERAL TERMS AND CONDITIONS FOR THE WORK OF SUPPLY, INSTALLATION, OF THE AUDIO-VIDEO EQUIPMENTS AT NGMA, NEW DELHI

- 1. The Tenderer shall be required to take up the work of Supply, Installation, of the Audio Video Equipment at NGMA, New Delhi.
- 2. Price:

The rates quoted/indicated shall include cost of materials and Installation, required for the work as per the enclosed specification and their supply & installation charges. The V.A.T./C.S.T./Service/Excise/Service Tax and other taxes/ levies to be imposed on the rate shall be clearly mentioned. Rate quoted shall be firm and fixed for the entire period of execution of the Work Order and no escalation of rate on any ground whatsoever shall be applicable. 3. Time of completion:

- 6. Defect Liability Period
