Sealed quotations are invited from authorised e-waste recyclers/dismantlers/collection agencies registered with the concerned State/Central Pollution Control Board/Pollution Control Committee for disposal/lifting of obsolete and unserviceable e-waste items accumulated in the office of the Director, National Gallery of Modern Art, (Subordinate office of the Ministry of Culture), #49, Manikyavelu Mansion, Palace Road, Bangalore-560 001.

1. Approximate quantity of e-waste : 300 Kgs (approx.)

### Terms & Conditions:

1. The bidder shall be an authorised e-waste recycler/dismantler/collection agency and shall submit a copy of valid authorisation/registration issued by the concerned State Pollution Control Board/Pollution Control Committee along with the quotation.
2. The e-waste shall be disposed of strictly in accordance with the provisions of the E-Waste (Management) Rules, 2022 and other applicable Government rules/orders.
3. The successful bidder shall lift the materials at their own cost and risk within 03 days from the date of issue of award letter.
4. This office shall not be responsible for any damage/loss caused during lifting or transportation of the materials.
5. The bidder shall inspect the materials before submitting quotation. No complaint whatsoever regarding quantity or quality shall be entertained after submission of quotation.
6. The competent authority reserves the right to accept or reject any or all quotations without assigning any reason thereof.
7. Payment shall be made by the successful bidder in favour of \_Director, National Gallery of Modern Art, Bengaluru before lifting the materials.
8. Conditional quotations shall not be considered.
